Pending Old Business:

- 1) **Inbond New Procedures suspended** – Any update on enforcement date?

New Business:

- 1) **Pedestrians via WTB:** It has been reported that pedestrians will no longer be allowed through WTB starting in May. Will an official notice be issued regarding this change?
- 2) **Monthly Bridge Crossing Statistics:** Other ports from other districts provide this information to the Trade. Can this be provided for the POE Laredo at our meetings? Is the data available elsewhere to view?
- 3) **CBMA Protest Process:** Could we be provided an update on the CBMA Protest process? We have been advised those protests with a refund of \$ 800.00 and over are being processed with priority. Also protests with multiple underlying entries are being distributed to different CBP CEE team IS throughout the US, resulting in separate/multiple inquiries.
