Pending Old Business:

New Business:

- 1) **Electronic Reporting of Exports/Arrivals/Diversions** = Effective July 29th.
 - Will a stamped 7512 be allowed as proof of export?
 - What will be the process for reviewing In-bond merchandise under the new guidelines (version 2)? Can the trade request a blanket request to review for a specific time frame?
 - Will Firms codes be required to arrive In-bonds on July 29th.

- 2) **Statement Summary without payment** – What are CBP's established procedures for Statement entry summary presentation when duty/fees are required but payment is not submitted.

- 3) **Reconciliations for Refund** - The Headers are not uploaded in DIS. CBP needs Trade input.

- 4) **CBP contingency plan when there are FDA issues** – On June 18th there were several brokers with trailers not released due to FDA issues without first consulting with FDA PNC. What contingency plan does CBP have to release the trailers if not an isolated incident. Does the broker contact MET? Contact ACS?

- 5) **What documents are required when addressing an entry not released by CBP but has been imported into the US?** In a request last week for entry release, the broker was asked to provide a signed US carrier's bill of lading after already providing the DODA date stamped as received by the US carrier.
