CBP Announcements:

PENDING OLD BUSINESS: None

NEW BUSINESS:

- 1) Government Shutdown. How will this affect the Trade? Can CBP confirm which departments and/or OGAs, if any, are fully / partially shut down due to the government shutdown?
- **2) ABI Reps not available due to governemt shutdown.** With the shutdown, no ABI Reps are available on a local or national level. ACE helpdesk is not able to help with any ABI issues. Does local CBP have an alternate plan assisting the trade with ABI issues?
- **3)** Annual District Permit and National Permit Fee Reminder due January **25.** Please confirm <u>who</u> needs to submit payment as well as the <u>options</u> for payment (is payment accepted online?).
- 4) High Security Seals. Has CBP replenished their high security seals?
- 5) **Inbond new procedures extended to February 2019.** Please provide any new updates to the procedures, if applicable.
 - a. **Supervised exports** Please provide an update on local procedures. Will inbonds be stamped at time of export if it is requested by the carrier?
 - b. **Proof of Export** Please confirm what will be the acceptable proof of export for Export Audits (Mexico's SOIA? *pedimento desglosado? etc*?).

- 6) Inbond incorrectly being self-exported by CBP System.
 - a. The inbond status changes to exported but a cargo manifest query states differently.
 - b. Errors where inbond was inadverdenatly exported by mistake, how can this be corrected?
- 7) FP&F Extensions for time sensitive procedures . Since Food and Drug Administration (FDA) does not have a FY 2019 appropriation or continuing resolution, and FDA may not incur any further financial obligations, except for those trade related to orderly suspension of FDA regulated operations, will CBP be allowing exceptions or extensions for FDA refused merchandise with a deadline during the Government shutdown?
